1968: SHRIMATI PRATIBHA SINGH:

Will the Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING मत्स्यपालन, पशुपालन और डेयरी मंत्री be pleased to state?

- (a) the details of various schemes being implemented by the Ministry with the details of funds allocated and spent under various schemes during the last three years, State-wise including Himachal Pradesh;
- (b) whether providing veterinary service/treatment is big challenge in rural/tribal areas and if so, the effective steps being taken in this regard; and
- (c) the details of the steps being taken by the Government for improving veterinary hospitals?

ANSWER

THE MINISTER FOR FISHERIES ANIMAL HUSBANDRY AND DAIRYING (SHRI PARSHOTTAM RUPALA)

- (a) The details of the various schemes being implemented by the Department of Animal Husbandry and Dairying, Ministry of Fisheries, Animal Husbandry and Dairying, Government of India in all States/UTs Including Himachal Pradesh are as under:
 - (i) **Rashtriya Gokul Mission (RGM):** Rashtriya Gokul Mission (RGM) focuses on development and conservation of indigenous bovine breeds, genetic upgradation of bovine population and enhancement of milk production and productivity.
 - (ii) **National Programme for Dairy Development (NPDD):** This programme is focused to enhance quality of milk and milk products and increase share of organized procurement, processing, value addition and marketing, productivity enhancement through nutritional interventions.
 - (iii) **Dairy Processing and Infrastructure Development Fund (DIDF):** This is focused on creation/strengthening/ modernization of Milk Chilling and Processing Plants, Value added Product making facilities, Energy efficiency infrastructure, Training facilities, Cattle feed Plant, etc.

- (iv) Supporting Dairy Cooperatives and Farmer Producer Organizations (SDCFPO): This is focused to provide working capital loan to State Cooperatives and Federations to assist the State Dairy Cooperative Federations and stable market access to the dairy farmers.
- (v) **National Livestock Mission (NLM):** National Livestock Mission (NLM) aims towards employment generation, entrepreneurship development, increase in per animal productivity and thus targeting increased production of meat, goat milk, egg and wool under the umbrella scheme Development Programme.
- (vi) Animal Husbandry Infrastructure Development Fund (AHIDF): The Animal Husbandry Infrastructure Development Fund (AHIDF) has been approved for incentivizing investments by individual entrepreneurs, private companies, MSMEs, Farmers Producers Organizations (FPOs) and section 8 companies.
- (vii) Livestock Health and Disease Control Programme (LH&DCP): Department implements the Livestock Health and Disease Control Programme (LHDCP), a Central Sector Scheme with the aim of reducing risk to animal health by prophylactic vaccination against diseases of animals, capacity building of Veterinary services, disease surveillance and strengthening veterinary infrastructure.

(viii) Livestock Census and Integrated Sample Survey (LC & ISS):

This involves complete count of the livestock and poultry at pre-defined reference point of time to ascertain the number of livestock/poultry possessed by every household / household enterprise / non-household / non-household enterprises and institutions by age, sex, use, etc. in rural & urban areas of the country. This also include the quantum of four major livestock products (MLPs) like Milk, Egg, Meat and Wool based on the annual sample survey both at National and State level.

The details of funds allocated and spent under various schemes during the last three years, state-wise including Himachal Pradesh are placed at **Annexure-1**

(b) As gathered from the states, there are challenges to some extent in rural/tribal areas and the states/UTs are establishing and strengthening the veterinary hospitals/dispensaries, placing Veterinary Doctors/ Para-Veterinarians, managing veterinary services through Mobile veterinary Units (MVUs), awareness and training programmes to improve veterinary care in such areas. Under Livestock Health and Disease Control Programme (LHDCP), a Central Sector Scheme, risk to animal health is reduced by prophylactic vaccination against diseases of animals, capacity building of veterinary services, disease surveillance and strengthening veterinary infrastructure. The major activities supported are: vaccination against Foot and Mouth Disease (FMD), Brucellosis, Peste des Petits Ruminants (PPR) and Classical Swine Fever (CSF); funds for establishment and operationalization of Mobile Veterinary Units (ESVHD-MVU) for last mile delivery of veterinary service; and Assistance to States for Control of Animal Disease

(ASCAD) for control of state prioritized economically important, exotic, emergent and zoonotic animal diseases.

(c) Animal Husbandry is state subject and the establishment and improvement of veterinary hospital is the domain of the state governments. However, Department of Animal Husbandry and Dairying under the component of Establishment & Strengthening of Veterinary Hospitals & Dispensaries-Mobile Veterinary Units (ESVHD-MVU) provides financial assistance to States/UTs for delivery of veterinary healthcare services at farmers' doorsteps to strengthen veterinary health services @ 1 MVU/1 Lakh livestock population. MVUs provide diagnosis, treatment, vaccination, minor surgical interventions, audio-visual aids and extension services to farmers / animal owners at their doorstep in far flung area. The Central Government has provided 100% financial assistance to the States/UTs towards procurement and customization of MVUs under Establishment and Strengthening of Veterinary Hospital & Dispensaries—Mobile Veterinary Units (ESVHD-MVUs) to further strengthen veterinary health services.
