(b) The details of the number of Gokul grams sanctioned / established under Rashtriya Gokul Mission particularly in the State of Uttar Pradesh, Madhya Pradesh and Maharashtra is given at Annexure-I.

(c) In order to propagate high genetic merit bulls following measures has been undertaken by Department of Animal Husbandry and Dairying: (i) Implementation of progeny testing programme to produce high genetic merit bulls with known genetic potential; (ii) Implementation of pedigree selection programme to produce high genetic merit bulls with known genetic potential; (iii) Production of high genetic merit bulls using bovine IVF technology; (iv) Implementation of genomic selection programme to prove genetic merit of bulls at younger age and propagation of high genetic merit germplasm.

(d) Department is promoting research and development in the field of bovine breeding through ICAR institutes, Government Veterinary Universities and National Dairy Development Board.
