Will the Minister of FISHERIES, ANIMAL HUSBANDRY AND DAIRYING be pleased to state:

- (a) the number of livestock insured under National Livestock Mission (NLM), year-wise and State-wise;
- (b) the number of insurance companies that have participated in NLM in the year 2022-23, State-wise;
- (c) the mechanism that has been established by Government for liquidation of Utilisation Certificates pending with States and UTs; and
- (d) whether Government has explored the possibility of developing an App-based Livestock Insurance facility for livestock owners, if so, the details thereof and if not, the reasons therefor?

- (a) Year-wise and State-wise details and number of livestock insured under National Livestock Mission for the last two years and the current year is enclosed at Annexure I.
- (b) The details of number of insurance companies that have participated in NLM in the year 2022-23, State-wise is enclosed at Annexure II.
- (c) For the liquidation of Utilization Certificates pending with States and Union Territories, the Department of Animal Husbandry and Dairying (DAHD), Government of India regularly conducts video conferences, monthly progress meetings, regional review meetings, sending official as well as demi official letters from higher officials. Further, the DAHD is strictly monitoring the expenditure of the States/UTs through various PFMS reports and not releasing fresh funds to avoid parking if the States/UTs are unable to utilize funds as per the existing guidelines of the Government.
- (d) The Government is in process of development of a comprehensive Livestock Insurance Portal which will be assisted through mobile App-based Livestock Insurance facility.
