(i)Experience: Firms should have minimum 02 years experience of providing refrigerated vans for transp ion of such Products. Experience Certificate may be enclosed.

(ii) Number of available fleet of Refrigerated Vehicles:- The participating bidder must be having at le 6 in numbers of Refrigerated Vehicles already available in the name of his firm and/or in the name of owner he firm in Registration Certificate for Refrigerated Vehicles.

**5. **6. **7. Security Deposit:** - The successful tenderer/bidder shall be required to deposit 5% security amoun otal annual contract value within 15 days from award of contract for due performance of contract in the shaf DD/PO/FDR in favour of General Manager, DMS, failing which the contract may be cancelled. ## 8. Period of contract:

- (b) Financial Bid/Price Bid:- Rate (inclusive of GST & all other charges) of Refrigerated vehicle on per KM basis (both side) may be offered in (.xls) of financial bid/price bid. Further, Price Breakup of quoted rate may also be provided on your letter head in (.pdf) of price bid on GeM-Portal.
- (c) It may be noted that tender of those bidders will be rejected if any bidder disclose their rate/price breakup in with technical bid. Hence rate & price breakup may be uploaded with financial bid only.

**4. Eligibility Criteria of the tender:-** The tenderer/bidder may submit the photocopy of following documents to ascertain the eligibility. Original may be produced for verification on demand.

(i)Experience: Firms should have minimum 02 years experience of providing refrigerated vans for transportation of such Products. Experience Certificate may be enclosed.

(ii) Number of available fleet of Refrigerated Vehicles:- The participating bidder must be having at least 06 in numbers of Refrigerated Vehicles already available in the name of his firm and/or in the name of owner of the firm in Registration Certificate for Refrigerated Vehicles.

(iii) Financial Turnover: Bidder should have average financial turnover of 03 years as specified in the GeM bid.

(iv) Other documents required with tender: The tenderer/ bidder may submit the copy of PAN card and Adhaar Card along with tender.

**Note:-** MSE and start-up are not exempted from eligibility criteria of experience, it being a tender for specialized services. However they are exempted from the eligibility criteria of financial turnover. However they will be given price preference as per Govt. Policy.

5. Rate:-Rate (inclusive of GST and other all taxes/charges) of Refrigerated vehicle may be quoted/offered on per km basis (both side) in price bid at appropriate place of GeM Portal for Transport of Milk and Milk Products from Ballabgarh Dairy (Haryana) to DMS Premises on daily basis. Further, Price breakup of the quoted rates may be uploaded on your letter head in (.pdf) of financial/price bid at appropriate place on GeM-Portal. There should not be any cutting/overwriting in rates/offer. It is the responsibility of transporter/contractor to timely pay/deposit the GST amount to concerned authority. The refrigerated facility will be included in transferring packed milk and milk products from Ballabgarh plant to DMS premises and no refrigeration required while transferring DMS empty crates/packaging material etc to Ballabgarh plant from DMS premises.

6. Earnest Money Deposit (EMD):- Micro and Small Enterprises (MSEs) as defined in MSE Procurement Policy issued by Department of Micro, Small and Medium Enterprises (MSME) or registered with the Central Purchase Origination or the concerned Ministry or Department or Start-ups as recognised by Department for Promotion of Industry Internal Trade (DPIIT) are exempted from depositing EMD. Proof of Registration as MSE/Start -up may be enclosed for exemption of EMD.

Further the other firms has to deposited EMD as specified in GeM bid in form of demand draft/pay order/FDR along with technical bid in favour of General Manager, Delhi Milk Scheme. Scan copy of the same may be uploaded/enclosed along with e-tender with technical bid. Hard copy of EMD may be submitted to the buyer within 05 working days of bid opening, failing which the bid may be treated as incomplete and may lead to rejection of the bid by buyer without making any reference to seller. Tender offer (Technical bid) without uploading scan copy EMD or exemption certificate shall not be considered.

7. Security Deposit: - The successful tenderer/bidder shall be required to deposit 5% security amount of total annual contract value within 15 days from award of contract for due performance of contract in the shape of DD/PO/FDR in favour of General Manager, DMS, failing which the contract may be cancelled. The Security Amount shall be refunded after successfully completion of the contract period and on submission of a "No demand certificate. No interest on security shall be paid by DMS.

#### 8. Period of contract:

- (i) The contract for outsourcing of vehicles shall be awarded initially for the period of (02) years. Basis on the satisfactory performance of the party, Contract may be further extended for three months under option clause of GeM bid.
- (ii) However, General Manager, DMS may cancel/terminate the above contract at any time under the following conditions mentioned below:-

a) on the breach of terms & conditions of the contract by the selected bidder/party,

b) in the event of handing over the O&M of DMS to any external agency,

c) termination of present MoU for 3P agreement of manufacturing and packing of DMS milk and milk products with Haryana State Dairy Federation and/ or

d) closure of DMS activities due to any reason by providing 15 days notice. Decision of GM, DMS shall be final and binding to all parties in this matter.

**9. Payments Terms:**-The payments shall be made on fortnightly basis duly certified by the Indenting/User/ Concern designated officer. Due payment to the transporter will be made as per GeM guidelines on receipt of the bills by the Indenting/User/ Concern designated officer. The payment will be made as per number of refrigerated vehicles actually deployed in DMS for above purpose on daily basis as per requirement.

- (i) <u>CONSIGNMENT LOST IN TRANSIT</u>: when a consignment is lost in transit and not delivered to the consignee within a reasonable period of time, the responsibility for loss of such consignment would entirely lie on the transport carrier. The value of such loss to the DMS, shall be entirely payable by the transport carrier and shall be recovered out of the pending freight bills of the carrier or through any other legal means. In other words, carriers would be fully responsible to make good such loss to the DMS.
- (ii) When required by the DMS, the refrigerated vans must be available with the requisite crew and in running condition and with all equipment functioning as per specifications.
- (iii) Penalty shall be imposed as decided by the DMS Management for delay in lifting/delivery at the destination point beyond the reasonable time limit.
- (iv) Cost of material shall be recovered from the pending dues in case of damage/pilferage/theft.
- (v) Payment shall be released within stipulated time period as specified by GeM after generation of bill on GeM Portal along with required documents.
- (vi) The rate quoted should be based upon prevailing diesel price/CNG applicable and shall be revised on pro-rate basis as and when the same is revised by the appropriate authority.
- (vii) No Detention charges shall be paid at any cost.
- (viii) Driver should possess valid HMV driving license, PUC certificates at all the time and can be checked within the DMS Dairy or while in transit.
- (ix) Necessary deductions towards income-tax / T.D.S. or service tax etc. shall be made from your payment as per provisions of the Acts in force from time to time.
- (x) Vehicle should be available at either of the two plants on 24X7 basis with driver.
- (xi) DMS will not be responsible for compliance of any kind of legal, statutory obligations for the staffs engaged by the transporter.

- (xv) This is completely a commercial contract, not for recruitment. No employee-employer relationship will be maintained between the transporter and the DMS. In addition to this the transporter has to follow the terms and conditions of the contract apart from this any instruction issued by the DMS will be followed by the Transporter.
- (xvi) If the Ballabgarh dairy plant is required to be closed under any circumstances like shortage of power, strike, lock-out or any natural calamity and if the transportation service gets interrupted, the DMS will not be liable to compensate any demurrage to the transporter.
- (xvii) The transporter will not carry any other items/goods than the materials provided by the DMS. If so, a suitable fine will be imposed to the transporter without assigning any reason, for each time.
- (xviii) If it is found that transporter /any staff of the transporter is involved /engaged in any kind of illegal activities then legal action will be taken accordingly and if any transporter /staff of the transporter misbehave with any officials of the DMS/Ballabgarh Dairy, then the particular staff will have to be dismissed immediately.
- (xix) If the transporter quits the job during the contract period, the demurrage cost due to this, will be collected from the transporter and the security money will be forfeited and a suitable penalty will be imposed.
- (xx) The transporter will provide standby vehicles in the event of any breakdown. After accepting the contract, if the transporter fails to engage the vehicle according to the work order, his/her security deposit will be forfeited and he/she will not be able to participate in any kind of tender for three years.
- (xxi) The transporter will be liable to submit all the necessary valid documents related to the vehicle such as legal permit, token, vehicle insurance, fitness certificate etc of the vehicle before engaging the vehicle.
- (xxii) No appeal for enhancement of rate will be entertained during the contract period. Due to any reason if the transport service is stopped or paused, the transporter has to pay the total transportation cost for any alternative arrangement made by the DMS and the security amount will be forfeited and suitable compensation will be imposed.
- (xxiii) The time table, for placing the vehicle to dock area at Ballabgarh Haryana for loading /unloading of milk and milk products and for dispatching to the said route, shall be finally decided by DMS and the transporter is bound to follow the instruction / time table.
- (xxiv) If required, the transporter will be liable to transport milk and milk products of other routes according to the challan and stipulated timetable provided by Distribution Section, DMS and at the time of carrying milk and milk products if any damage occurs, the transporter will be liable. In this case the approved rate of that route / type of vehicle will be considered.
- (xxv) The transporter will be fully responsible for any demurrage of milk and milk products for negligence to arrange the alternative vehicle or any other negligence from the end of the transporter or his/her stuff. The demurrage and penalty amount will be decided by the DMS and it will be deducted from the monthly bill of the transporter.
- (xxvi) During the transit the transporter shall not carry any passenger or any other materials without permission of DMS. If the transporter or his/her staff is associated with any illegal activities or any accidents, DMS will not be responsible morally/legally regarding the aforesaid matters.
- (xxvii) The transporter shall have to maintain one reserved space in the transporting vehicle for one of the official of the DMS and in case of any accident, the rules of Motor Vehicles (MV) act will be followed.
- (xxviii) If the engaged vehicle of the transporter is unable to supply milk and milk products due to any reason whatsoever then the transporter has to arrange an alternative vehicle to continue the transport service. If he fails to do so, he will be liable to pay the amount of extra expenditure incurred by the DMS in arranging such alternate vehicle along with penalty as fixed by the DMS. The corresponding amount along with penalty, if any, will be deducted from the bill of the transporter.

- (xxix) If the service of the transporter is not found satisfactory or it is adverse to the interest of the DMS then the DMS may terminate the contract at any point of time, without assigning any reason. On termination of the contract the Security Deposit shall be forfeited and the transporter shall be blacklisted for 3 years and no claim in this regard shall be entertained.
- (xxx) **Transportation of Empty crates**: Transporters are required to carry the empty crates/other Milk Products from DMS to Milk Union Ballabgarh on daily basis during their return trip.
- (xxxi) Only sealed Refrigerated vehicle will be allowed to operate. Security of each Refrigerated vehicle will be done by DMS staff responsible.
- (xxxii) De-sealing of Refrigerated vehicle will be done in DMS, C.D. by DMS staff.
- (xxxiii) Temperature mentioned in the GeM tender shall be strictly be maintained.
- (xxxiv) During transit if FSSAI/Any Govt. Authority stopes/checks the vehicle and temperature of packed milk & Milk Products inside the van/vehicle is found beyond what has been prescribed then the penalty/legal case if any shall be the responsibility of Refrigerated van/vehicle provider.
- (xxxv) Tempering of pouches inside the Refrigerated van/vehicle in transit shall be the sole responsibility of the party.
- Insulation: Transporter must provide stipulated capacity suitably refrigerated vehicle within a period of 15 days from the date of allotment of A/T or job order. The vehicles should be registered in the year 2022 (BS VI) Model or later for Diesel vehicle and year 2022 Model or later for CNG vehicle.

15. Arrival Timings of Vehicles:- The vehicles should reach DMS premises to at 11:30 PM From Ballabgarh Dairy Plant on all days or as per time schedule given by Sr.TO, DMS. The transporter should ensure that the supply is made as per schedule timing fixed for summer and winter seasons by Manager (Distt.) or his representative. The timing may changed/ vary as per DMS's requirements and transporters are to adhere the changed timing of DMS

16. **Excess Quantity:** Transporter is bound to carry the 10% excess quantity of crates on awarded rate, terms and condition without claiming any extra payment. However, Transporter may carry additional quantity of packed milk & milk products as per their capacity.

#### 17. Penalties:-

- i.) Any failure on the part of the contractor in providing the required number of vehicle on any day, a penalty of Rs.10,000/- per route per day shall be charged and same shall be recovered from his pending bills/security. Further General Manager, Delhi Milk Scheme or his authorized officer shall have the right to engage the required number of vehicles to get the job done from the open market at the risk and cost of the contractor in the manner it deems fit and he shall be fully responsible for making good the losses. Such payments shall be adjusted in payments bills.
- ii.) Late arrival of Vehicles for deployment beyond 30 Minutes will be penalized and 10% of the Hiring charges will be deducted from the bills of the party for the day they report late. The decision of the Senior Transport Officer or designated officer will be final whether to allow such vehicles or not on that day.
- iii.) In case the vehicle is found to be driven by a person not holding a valid driving license in DMS premises, a penalty of Rs.1000/- per incident detected shall be charged apart from taking other action.
- iv.) Physical Condition of the vehicle should be good, which committee of DMS team security + transport + distribution would check regularly or any committee formed by DMS officials. In case of unsatisfactory condition Rs.2000/- per day/per vehicle would be penalized till it becomes satisfactory.
- v.) If the vehicle is found without proper refrigerated, a penalty of Rs.5000/- will be charged per day.
- **18. Behaviour & Manners:-**The contractor's behaviour should be very cordial and helpful with the customers/Distributor Milk Union and DMS Staff. In case any misconduct or misdeed is reported and confirmed, the agreement can be terminated by giving ten days notice.
- **19. Insurance:-** The vehicle should have Comprehensive Insurance Policy for which they have to give a documentary proof in the form of insurance cover after the Job is awarded to Sr. T.O.
  - i.) The transporter shall be responsible for meeting all the conditions laid down by Govt./Delhi Police/Court order from time to time and DMS will not be liable to provide any technical help. However, administrative help as desired will be provided to have smooth service to customers.
  - ii.) A vehicle deployed on Govt. duty under DMS will not be used for any other job other than transportation of DMS milk & milk products during the prescribed period of contract.
  - iii.) Painting: The contractor providing the vehicles shall paint the vans as per the condition of transport department and keep the vehicle in proper shape. He will also ensure Annual Painting of the Van.
  - iv.) Cleaning: Goods carrying area of the vehicle should be kept neat & clean and dry and the same should not be damaged. There should be proper lighting arrangement in milk carrying area of the vehicle.
  - v.) **No Entry Permission:-**This is the primarily duty of the contractor to arrange No Entry Permission from the concerned department. However, DMS shall assist in getting the same.
  - vi.) No transportation/handling loss will be allowed.

- vii.) The Transporter shall strictly comply/adhere to the provisions of the amended Motor Vehicles Act, 1988. The responsibility of any violation of the provisions of the said Act will be solely of the transporter.
- viii.) These terms and conditions will not mitigate or abrogate in any manner the responsibility under the carriers Act 1865 as amended from time to time in respect of the goods entrusted to the transporter for delivery under the contract.
- ix.) **Impounding of Vehicles**: The vehicles of the contractor can be impounded in case of any misshappening or any breach of the terms and conditions of the contract or any default or un-lawful activities by the contractor/his staff, with the orders of General Manager, Delhi Milk Scheme.
- x.) Additional Services:- The Additional Service of the vehicles of the contractor can also be utilised for other activities such as for transportation of SMP/Butter Oil/White Butter other activities within Delhi/NCR at the same rates, terms and conditions. The contractor should arrange vehicles as and when required during the period of the contract.
- xi.) Under Carriage by Road Act 2007- The transporter has to abide by the under carriage by road Act-2007.

### 20. General Legal Points:-

- (a) The contractor shall be solely and exclusively liable for the payment of any and all taxes hereafter imposed, increased or modified from time to time and all Income Tax, Service Tax, now in force and hereafter increased, and all contributions and taxes for un-employment compensation, insurance and old age pensions or annuities now or hereafter imposed by the covered by the wages, salaries or other compensation paid to person employed by the contractor.
- (b) The Contractor shall exclusively by liable and responsible for his Employee's wages PF, Bonus, Medical, Uniforms and full compliance in their respect with all statutory laws, rules and regulations as applicable to them.
- 21. Right to Accept/Reject/Modify offers: DMS reserves the right to accept or reject any offer or to annul the bidding process and reject all bids at any time prior to contract award, without thereby incurring any liability to the bidders.
- 22. Short Close of Contract:(i) On breach of any terms and conditions, the said contract can be short closed/cancelled at any time without assigning any reason at the sole discretion of General Manger, Delhi Milk Scheme.

(ii) The contract can be short closed under following conditions:-

a) in the event of handing over the O&M of DMS to any external agency,

b) termination of present MoU for 3P agreement of manufacturing and packing of DMS milk and milk products with Haryana State Dairy Federation and/ or

c) closure of DMS activities due to any reason by providing 15 days notice. Decision of GM, DMS shall be final and binding to all parties in this matter.

- 23. Alteration of Terms and Conditions:-General Manager, Delhi Milk Scheme reserves the right to add/modify any term considered reasonable and in public interest which shall be intimated to the transporter during the period of the contract and the same shall be binding on contractor.
- 24. Submission of documents by bidders on GeM Portal against above GeM bid:
- (i) Scan copy of requisite EMD or exemption certificate etc. should be uploaded in (.pdf) in technical bid offer, failing which the offer shall be rejected summarily.
- (ii) Scan copy of all documents as per terms & condition of Tender i.e. proof of eligibility criteria like Experience Certificate, Registration of Refrigerated Vehicles in name of proprietor/owner/firm as per eligibility criteria, Financial Turnover Certificate, Aadhar and Pan Card are to be uploaded in (.pdf) in technical bid offer.
- (iii) Rates is to be quoted in price bid offer only. Rates (with price breakup) may also be uploaded in (.pdf) of financial bid / price bid appropriately.
- (iv) Bidders are to ensure that no rate offer is quoted in the Technical Bid offer failing which, their Technical bid will be rejected summarily.
