1. 4. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.

5. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant /

Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria. 6. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

7. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

9. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 20% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. The category has been created in accordance with the Model Technical Specification issued by the Ministry of Electronics and Information Technology (MeitY) vide letter no. W-43/4/2020-IPHW dated 19th August 2024, and is based on the parameters defined therein. The specifications applicable to this category are as per the MeitY Model Technical Specification dated 19th August 2024. Accordingly, buyers shall not specify or mandate any particular processor, processor brand, or manufacturer in the Additional Terms and Conditions (ATC). In this context, reference may also be made to Clause 2(e) of the GeM General Terms and Conditions (GTC), which inter alia states: "The Specifications shall identify the key parameters defining the products with all necessary validations related to configuration, type of data, restrictions, range / allowed values, allowed units etc. Sellers as well as Buyers while offering / buying the Goods / services shall have to comply with the validation rules / restrictions provided for in the Category Specification." In view of the above, buyers are not permitted to amend or modify any technical specification through the Additional Terms and Conditions Terms and Conditions."

2. <u>Rates to be offered for material</u>: Bidders are required to quote rates per unit / items of goods (i.e. 33 in Nos. Computers / Desktop, 28 Printers and 22 Scanners) in price bid on FOR Delhi Milk Scheme, inclusive of GST, packing forwarding, Transportation, Unloading etc. Further, rates (with price breakup) may be quoted inclusive of GST, packing forwarding, Transportation, Unloading etc in (.pdf) of financial bid / price bid.

3. **Delivery Schedule for supply:** The shortlisted bidder is required to supply the above items mentions at para 1 above (i.e. 33 in Nos. Computers / Desktop, 28 Printers and 22 Scanners) in 45 days from the date of issue of contract order. Delivery Period is the essence of the contract which must be adhered to.

4. <u>EMD to be deposited with Tender</u>: Bidders are required to upload scanned copy of Earnest Money Deposit (EMD) as mentioned in GeM bid along with their technical bid. Bidders are required to ensure the delivery of hard copy (original) of EMD in the form of Demand Draft / Banker Cheque / FDR drawn in favour of 'General Manager, Delhi Milk Scheme' within 5 days of Bid End date/ Bid Opening date.

5. <u>Performance Security Deposit</u>: Successful bidder will be required to deposit a sum amounting to 3% value of the contract as a Performance Security Deposit in the form of Bank Draft / Pay order / DD or Bank Guarantee valid for 38 months from date of delivery of the item in favour of General Manager, Delhi Milk Scheme, West Patel Nagar, New Delhi-110008 within 15 days of award of contract. As usual Security Deposit will be released after completion of the contract including the successful performance of the guarantee/ warranty & on submission of "No Demand Certificate". Please note that no claim shall lie against the Government in respect of interest thereon nor any loss or depreciation thereof while the Security Deposit remained in the custody of the Govt.

6. <u>Eligibility Criteria of Bidders</u>: The Tenderer / Bidder may submit the photocopies of following documents to ascertain the eligibility along with their technical bid. Original may be produced for verification on demand.

(i) <u>Experience</u>: Biddershould have two years experience of supply of computers and/ or peripherals (i.e. Computers/ Desktops, Printers and Scanners etc.) to Govt. organizations/ PSU's/ Private Limited Companies etc. Copy of job orders, contracts, job completion certificates etc. may be enclosed as a proof of experience. MSEs / Startups firms are exempted from experience eligibility criteria of tender.

(ii) <u>Financial Turnover</u>: The firm should have average Annual Financial Turnover in last three financial years (i.e. 2021-22, 2022-23 and 2023-24) as mentioned in GeM Bid. Copies of last three years Annual Accounts (i.e. Profit and Loss Statement, Balance Sheets and Income Tax returns received by I.T. Department / Income & Expenditure Account prepared in place of Profit & Loss A/C but not in place of Balance Sheet) may be enclosed. MSEs / Startups firms are exempted from Financial Turnover of tender.

(iii) The copy of GST Certificate of firm is to be enclosed alongwith technical bid.

7.**Two Bid System**: Above GeM Bid is invited on two bid system basis i.e. technical bid and financial bid.

(a) <u>Technical Bid</u>: Technical Bid consisting of all technical details (i.e. certificate/documents in support of eligibility as per terms & conditions of tender like Experience Certificate, Financial Turnover and GST Certificate), necessary EMD or exemption certificate etc. and compliance as per para 1 (i.e. Description of Stores) on OEM letter head are to be uploaded/ submitted alongwith Technical Bid. Conditional bids and / or bids having deviations from the specifications mentioned in GeM Bid and ATC shall not be accepted. Bidders quoting rates in Technical Bid offer shall be rejected summarily.

(b) <u>Financial Bid/ Price Bid:</u> Financial bid of only those parties shall be opened who fulfill the eligibility criteria and found eligible / responsive during evaluation of technical bid. Rates per unit / items of goods may be quoted in price bid. Bidders may additionally upload the rates (with price breakup) in .pdf of financial bid / price bid appropriately. The L-1 offer shall be decided on the basis of the lowest offer received for all the items/ goods (total wise evaluations) require to be purchased through this bunch bidding.

9. Rates may be offered in the financial / price bid. Rates may be quoted per unit of the goods for delivering the same in <u>Delhi Milk Scheme, West Patel Nagar, New Delhi</u> inclusive of GST, Packing, Transportation and Octroi etc.

10. The suppliers are required to supply the entire quantity within 45 days from the date of issue of contract. LD Charges as applicable may be levied in case of delayed supply on the sole discretion of General Manager, DMS.

11. In the event of breach of any of the terms and conditions of the contract by the contractor, General Manager, Delhi Milk Scheme is empowered to terminate the contract at the risk and cost of the contractor.

12. <u>Exemption of EMD:</u> Micro and Small Enterprises registered with District Industries Centers or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom or any other body specified by Ministry of Micro, Small and Medium Enterprises are exempted from depositing EMD and experience certificate. These Firms shall be given due consideration as per Public Procurement Policy for Micro and Small Enterprises (MSEs) order 2012. Further, Startups as recognized by Department of Promotion of Industry Internal Trade(DPIIT) are also exempted from depositing EMD and experience certificate. Proof of registration as Micro and Small Enterprises and startups may be enclosed.

13. **MODIFICATION**: In case of any hardship/operational problems faced by either party (i.e. contractor or DMS). General Manager, DMS has the right to add/modify any conditions in the public interest by recording reasons to this effect.

14. **<u>SHORT CLOSE OF CONTRACT</u>**: The contract can be short closed by giving a notice period of 07 days in the following circumstances:

(i) On breach of any terms and conditions from bidders, the said contract can be short closed / cancelled at any time without assigning any reason at the sole discretion of General Manager, Delhi Milk Scheme.

(ii) In the event of handing over the Operation & Management of DMS to any external agency.

(iii) In the event of closure of DMS activities due to any reasons.

(iv) In the event of termination of third party agreement / MoU for manufacturing and supply of milk and milk products of DMS with Haryana Dairy Federation.

(v) In the event of any other unforeseen circumstances beyond the control of DMS.

### 15. Submission of GeM Bid:

(i) Scan copy of requisite EMD or exemption certificate etc. should be uploaded in (.pdf) in technical bid offer.

(ii) Scan copy of all technical details (i.e. certificate/documents in support of eligibility as per terms & conditions of tender like Experience Certificate, Financial Turnover and GST Certificate), necessary EMD or exemption certificate etc. and compliance as per para 1 (i.e. Description of Stores) on OEM letter head are to be uploaded/ submitted alongwith Technical Bid.

(iii) Conditional bids and / or bids having deviations from the specifications mentioned in GeM Bid and ATC shall not be accepted.

(iv) Rates is to be quoted in price bid offer only. Rates (with price breakup) may also be uploaded in (.pdf) of financial bid / price bid appropriately.

(v) Bidders quoting rates in Technical Bid offer shall be rejected summarily.
