Subject: 6th amendment in the Implementation Guidelines of Animal Husbandry Infrastructure Development Fund.

In pursuance of the decisions taken in the thirteenth Project Sanctioning Committee (PSC) constituted under Animal Husbandry Infrastructure Development Fund (AHIDF) held on 30.01.2025, under the Chairpersonship of Secretary, Department of Animal Husbandry and Dairying, Government of India, the following amendment has been made in the existing implementation guidelines 3.0 for Animal Husbandry Infrastructure Development Fund (AHIDF) issued on 14.01.2025 for implementation of AHIDF:

2. Para 8.4 at page no 7 under implementation guidelines 3.0 for Animal Husbandry Infrastructure Development Fund (AHIDF) may be read as under:

Point No.	Existing clause	May be read as
Para 8.4 at page no 7 under implementation guidelines 3.0 for AHIDF	Eligible proposals, which have been sanctioned by the banks, however, the entities could not submit the proposal on the portal shall be allowed to avail benefits under the Scheme, which have received sanction for term loan by the banks /lending institutions. For any proposal received under the scheme, term loan sanction date should be the scheme notification date i.e 24.06.2020 onwards	For any proposal received under the scheme, term loan sanction date should not be before 01.04.2023 with effect from 01.04.2025. Projects which are already applied and marked eligible by the department are exempted from the above mentioned condition
