1. **Description of Material**: The detail of inventory is mentioned below:

Special Terms & Conditions of sale tender:

- 1. **Earnest Money Deposit**: Bidders /Buyers are required to deposit the EMD of Rs.30,000/-(Rupees Thirty thousand only) alongwith technical bid. The technical offer / tender without EMD shall not be accepted. The bidder seeking EMD exemption, must submit the valid supporting document. Under MSE category, only manufacturers for goods and Service Providers for Services are eligible for exemption from EMD. Traders are excluded from the purview of this Policy. Therefore only manufacturers of Goods shall be consider for exemption under MSE category.
- 2. <u>Rate offered</u>: Rate to be filled in financial bid on per litre basis and will be inclusive of all taxes, transportation and Government levies. Rates is to be quoted in financial /price bid only. **Rates quoted in technical offer shall be rejected summarily.**

3. Eligibility Criteria/ Documents required from of the bidders/ Buyers:

- 4. <u>Two Bid Systems</u>: Above E- tender is invited on two bid System basis i.e. technical bid and financial bid.
- (a) <u>Technical bid</u>: Following documents are required to be submitted along with Technical bid offer:
- (i) Tender documents (i.e. Tender acceptance letter and Tender documents) duly singed by bidder. Tender document (i.e. Tender acceptance letter and Tender documents) not signed by bidder shall not be considered/ accepted.
- (ii) Photo copy of GST, PAN card and Aadhar Card alongwith technical Bid.
- (iii) Photocopy of necessary EMD as mentioned at para 1 of Special Terms & Conditions of the tender is to be enclosed in technical offer at appropriate place on CPP-Portal. Original copy of EMD is to be submitted on or before opening of tender date, failing which their tender will be rejected.
- (iv) Undertaking in prescribed format attached to tender documents that the Diesel purchase shall be utilized for commercial activities and / or for utilization in industrial / transportation and under no circumstances it shall be misused for environmental pollution or un-authorized activities as per prevailing rules.

- (b) <u>Financial bid/Price bid:</u> Financial bid of only those party's shall be opened, who fulfil the technical eligibility criteria of the tender. Further, Bidders are required to quote Rate on per litres basis and will be inclusive of all taxes, transportation and Government levies on 'As is where is basis' in price / financial bid in (.xls) at appropriate place. The bidders are also required to upload the price break-up in (.pdf) on their letter head/ signature of financial bid on CPP-Portal i.e. eprocure.gov.in/procure/app at appropriate place. Further, if any bidder / buyer submit his/her rates in technical bid, such bid will be rejected summarily.
- 5. 'As-is-where-is' Basis: Notwithstanding anything contained in the e-auction or advertisement issued on the description and particulars of material for sale, the sale is on an 'As-is-where-is' Basis only, and the principle of caveat emptor (let the buyer be aware) will apply. 'As-is-where-is' means that the description /quality / Quantity indicated is approximate, and the seller does not give any assurance or guarantee that the material will strictly adhere to the details given in the advertisement or e-auction. All items shall be taken delivery of from the site by the successful bidders, with its faults and errors in description, if any. Neither can the sale be invalidated, nor can the bidder make any claim/compensation, whatsoever, on account of any defect in description or deficiency in the quantity and quality. No plea of misunderstanding or ignorance of conditions put forth after confirmation of sale shall be accepted.

- 6. **Quantity to be offered/ purchased by bidders**: Bidders / Buyers are required to offer rates for entire quantity of material 'As is where is basis'.
- 7. <u>Inspection by Bidders / Buyers</u>: In view of above 'As is where is' condition of the Tender, bidders are advised to quote rates only after inspection of items at the site. The bidder or his authorized representative may inspect the materials between 11 A.M to 4 P.M. (excluding lunch

hours) on any working day at the DMS Central Dairy. The prospective bidder may contact concerned officers / officials i.e. Dairy Engineer / DGM(T), DMS or ASO (Salvage), DMS regarding any query on Diesel for sale.

General Terms & Conditions of sale tender:

- 1. Rate & Service Tax: Rates are to be quoted with all inclusive of Service Tax and govt. levies etc.
- 2. <u>Tender without EMD</u>: Party has to submit the required EMD along with tender offer in the shape of Demand Draft/Banker's Cheque /FDR drawn in favour of General Manager, Delhi Milk Scheme. The tender offer not accompanied with requisite EMD will be summarily rejected. The EMD may be treated as part payment towards the purchase cost of material and the balance payment of the material shall be required to be deposited by successful bidders.
- 3. <u>Security Deposit</u>: The contractor is required to deposit the security amount of 25% of the total value of the contract within 07 days of issuance of acceptance letter / sale order (excluding the date of issue).
- 4. Balance Sale Value (BSV): EMD submitted alongwith tender and Security Deposit may be treated as part payment of sale value of the material. Further, the successful Bidders / Purchasers shall have to deposit the Balance Sale Value (BSV) within 15 days from the date of the issue of tender acceptance letter/ Sale order. The Charges @1% per week or part thereof upto two week only shall be imposed on the Balance Sale Value (BSV) if it is delayed beyond the specified date. If the said balance sale value is not deposited within two weeks of delay period, the security amount including the EMD amount treated as part payment will be forfeited without any further notice. Further, after receipt of entire Balance Sale Value (BSV), the formal Job order / delivery order shall be issued.
- 5. **Period of Contract:** The party shall purchase and lift the above material for sale within 30 days from the date of issue of Delivery Order. In case party fails to purchase & lift the accumulated quantity within the above stipulated period, the ground rent @ Rs.2% of the contract value on the remaining quantity per week and a portion thereof shall be imposed and party will be liable to pay the same over and above the value of the scrap. It means that party shall purchase and lift the accumulated quantity within 30 days period. GM, DMS may waive off the imposition of ground rent in genuine cases and decision of GM, DMS shall be final in such cases.
- 6. Variation in Available Quantity: At the time of delivery, the actual quantity of diesel may vary from the quantity mentioned in the delivery order. In case of excess available material, the seller reserves the right to retain material more than quantity in the lot at its discretion. The purchaser may be allowed to lift the additional quantity after making the requisite additional payment to the seller. If the quantity in a lot on actual weighment or count is less than the announced quantity, the seller will not make good the deficiency under any circumstances. The purchaser thereof will be entitled to obtain a refund for the undelivered quantity at the quoted rate. No interest will be paid on the amount of short delivered quantity.
- 7. <u>Seller's Right to reject all Bids</u>: The seller reserve the right to accept/reject and cancel any bid, amend the quantity or withdraw the bid at any stage before or after acceptance of bid/issue of acceptance letter/sale order/deliver order/deposit of the full sale value by the bidder, without assigning any reason thereof and the value of such material, if paid for, shall be refundable. The

- seller shall not be responsible for damage/loss to bidders on account of such withdrawal at any stage from the sale.
- 8. <u>All Expenses at Risk & Cost of the Buyers</u>: As the sale / disposal of material is on 'As is where is basis', therefore all the expenses like transportation, loading and unloading, engagement of labours for the job shall be at risk and cost of the Bidders / Buyers. DMS will not be responsible for any such activity.
- 9. All risks to the Buyer: The items shall remain in every aspect, at the risk of the buyer from the time of acceptance of his offer. The seller will not undertake any liability whatsoever for the safe custody, protection or preservation after the sale has been confirmed. Lots are put up for sale, subject to change by nature's wear and tear. No complaint regarding the quality or description of the material sold will be entertained once the bid has been accepted.
- 10. Clarification / Negotiations: Delhi Milk Scheme reserves the right to call upon the tenderer (s) through negotiations or otherwise about any of the points in the tender requiring clarifications / modifications and the tenderer (s) shall be responsible to attend to the same within the time and dates specified. Any clarifications / modifications made to the tenders at the time of negotiations shall be deemed to be part of the tender for enforcing the provisions in this tender. General Manager, Delhi Milk Scheme may accept or reject such alternations/modifications of the tenderers as he deems fit and shall not be bound to give any reasons thereof for the same. If any of the tenderer (s) who were requested to offer clarifications/attend negotiations did not do so with the time specified for the purpose, Delhi Milk Scheme is not bound to give such tenderers any further opportunity and shall be free to consider such tenders on its original alongwith those of others.
- 11. Excise Duty and Taxes: Any statutory variation in the rate of taxes / duties are to be borne by the purchaser. Tax rates indicated in the e-auction catalogue or Tender advertisement are only indicative and the actual Tax rates as applicable on the date shall be payable by the successful bidders directly to the seller at the time of taking delivery of materials.
- 12. Requirement of Statutory Laws for disposal of material: Tenderer /Bidders shall follow the guidelines/notifications issued by the Central Pollution Control Board (CPCB)/ Ministry of Environment, Forest and Climate Change (MoEFCC) from time to time for utilization / disposal of said material. The contractor is required to abide by all statutory requirements as per Law applicable during the contract period. DMS has no responsibility in case of any statutory violation by purchaser / bidder.
- 13. The successful parties shall have to purchase and lift the material after depositing the full payment of the material with Account Officer (Cash R) during working days before 13.00 P.M.
- 14. The Party shall have to purchase and lift the entire material on "As is where is basis" within 30 days from the date of issue of the job order failing which the EMD deposited by the bidder shall be forfeited and credited into government account.
- 15. The party may note that collection/lifting/loading of above item shall be done under the supervision of Dairy Engineer or his representative, Assistant Store Officer or his representative and representative of IAO and Security Officer.

- 16. All the expenses like transportation, loading and unloading engagement of labours for the job shall be at contractors cost.
- 17. **Statutory Requirement:** The contractor is required to abide by all statutory requirements as per Law applicable during the contract period.
- 18. <u>Modification</u>: In case of any hardship/operational problems faced by either party (i.e. contractor or DMS). General Manager, DMS have the right to add/modify any conditions in the public interest by recording reasons to this effect.

- 20. **Online Tender:** Only online tenders are allowed. No manual tender shall be accepted.
- 21. <u>Validity of Tender</u>: Your Tender offer should be valid for a period of 180 days from the closing date of tender.
- 22. <u>Jurisdiction</u>: All disputes arising out of or touching on the contract shall be subjected to the jurisdiction of the court of Union Territory of Delhi only.

- f.
