Office Memorandum

Subject: Grant of vigilance clearance to the officers of Central Public Sector Enterprises (CPSEs) for their applications for Board level posts in CPSEs.

This Department had earlier issued consolidated and revised guidelines regarding Vigilance Policy for CPSEs vide OM of even number dated 21st July 2025, which in its paragraphs 4.1 to 4.3 stipulated the grounds for denial of vigilance clearance to officers of CPSEs in certain cases including in matters of appointments to sensitive posts. It is understood that the Department of Personnel & Training (DoPT) in its OM No. 104/33/2024-AVD-IA, dated 9th October 2024, has stipulated certain grounds on which vigilance clearance shall be denied to members of All India Services (AIS)/ Central Civil Services/ Central Civil posts. These grounds for denial of vigilance clearance, in the aforesaid DoPT OM No. 104/33/2024-AVD-IA, dated the 9th October, 2024, however, do not apply to CPSE posts.

- 2. Based on the latest instructions issued by the DoPT, laying down the grounds for denial of vigilance clearance, some of which are already covered in this Department's OM dated 21.07.2025 and BPE Letter No. 15(7)/85-GM dated 19.09.1998, it has been decided with the approval of the competent authority in this Department, to add the following further grounds on which vigilance clearance shall be denied:
 - I. If the Officer fails to submit his annual immovable property return of the previous year, latest by 31st January of the following year.
 - II. In cases where there is a complaint, which is verifiable/ has been verified, against the officer involving corruption, possession of disproportionate assets, misappropriation, forgery/ cheating, moral turpitude and violation of conduct rules (However, vigilance clearance shall be granted if the preliminary inquiry in not initiated within three months);
- III. The officer is under suspension;
- IV. The officer is on the ODI (Officer of Doubtful Integrity)/ Agreed List;
- V. Disciplinary proceedings have been initiated against the officer with the issuing of chargesheet and proceedings are pending;
- VI. Orders for instituting a criminal case or sanction for investigation/ inquiry against the officer have been approved by the competent authority and the charge sheet is served within three months;
- VII. Charge sheet has been filed in a court by the Investigation Agency in a criminal case and the case is pending;

- VIII. Sanction for prosecution has been granted by the competent authority in PC Act 1988 (amended in 2018) or any other criminal case and the trial is pending;
 - IX. The officer is involved in a trap/ raid case on charges of corruption and Investigation is pending;
 - X. An FIR has been filed on the basis of a private complaint and charge sheet has been filed by the investigating agency in court of law;
 - XI. An FIR has been filed or a case registered by concerned competent authority against the officer, provided the charge sheet is filed within three months;
- 3 All administrative Ministries / Departments are requested to take necessary action and also bring the contents of this Office Memorandum to the notice of CPSEs under their respective administrative jurisdiction for information and compliance under intimation to this Department.
- 4. This issues with approval of the Secretary, Department of Public Enterprises.

Kindly refer to the D.O. letter dated 05.08.2022 circulating therewith Minutes of the Internal Meeting dated 04.02.2022 regarding shortlisting criteria for the posts of Director (HR)/ Director (Pers/IR). A copy of the Minutes are enclosed again for ready reference. It may be seen that as per the decision, the applicants for the above posts are required to be segregated into 3 categories on the basis of experience possessed by them and slots allocated amongst candidates falling under these categories.

- 2. In the recent past, it has been observed that many applicants are not mentioning those information of their experience in their applications, which are crucial for placing them in either of the 3 categories. As a result shortlisting their names for the post becomes difficult.
- I would, therefore, request you to kindly circulate the decision of PESB dated 04.02.2022 amongst the prospective candidates for the post of Director (HR)/ Director (Pers/IR) with a request to provide requisite information in relevant column of their application form, whenever they apply. Nodal officers of your Ministry/ Deptt/ CPSE may also be directed to ensure that information crucial for segregation of applicants are indicated by them in remarks column, while forwarding applications.



Minutes of Internal Meeting held on 04.02.2022 regarding shortlisting criteria for the posts of Director (HR)/ Director (Pers/IR)

A Board meeting to discuss the shortlisting criteria for the posts of Director (HR)/ Director (Pers/IR) was held on 4.2.2022. During the meeting the following three categories of applicants were clearly defined and agreed upon.

Category-I:

Priority to applicants with 5 years experience during the last 10 years in

HR/IR/Personnel.

Category-II:

Applicants with minimum 2 years' experience in HR/IR/Pers + 3 years as functional

head of projects / plants having direct responsibility of 1000 workforce.

Category-III:

Applicants having experience as functional head of projects / plants having direct

responsibility of at least 20% of the workforce.

- 2. During the meeting the Board also discussed matter pertaining to the distribution of the 6 slots allocated Internal Candidates. It was agreed that 3 slots will be allocated to Category-I and the other 3 slots will be allocated to Category-II and III. It was also decided that Chairperson will work out the details. Accordingly, the following principles for shortlisting have been drawn:
- A. The 6 slots allocated for Internal candidates will be distributed as per the following details:
 - 3 Slots will be reserved Category-1
 - (ii) The next 3 slot will be distributed to applicants from Category: II & III in the following order of priority:
 - (a) 1st priority to Category II
 - (b) 2nd priority to Category III
- B. In the event there are not enough applicantsunder Category-I the vacant slots will be distributed in the following order of priority:
 - (i) 1st priority to Category II
 - (ii) 2nd priority to Category III

However, the slots for category-II & III will not exceed 3 each in the event there are no/not enough applicants from Category-I

- C. Further, in the event where there are not enough applicants from Category-II & III, the vacant slots will be allocated to applicants under Category-I, if applicants are available.
- 3. The above categorization principles will be applied in prioritization for shortlisting of Sectoral, External, Central Government/SPSE/Private-Category-I first priority followed by Category-II and Category-III, in that order.
