

Subject:-Filling up of one post of Secretary, Animal Welfare Board of India, Ballabgarh, Haryana (Level-12, Rs. 78,800 – Rs. 2,09,200 of the Pay Matrix) on deputation basis - regarding.

The undersigned is directed to state that it has been decided to fill up one post of Secretary, AWBI, General Central Service Group "A" Non-Gazetted (Non-Ministerial) in Level-12, Rs. 78,800 – Rs. 2,09,200 of the Pay Matrix at Animal Welfare Board of India (AWBI), Ballabgarh (Haryana) under the Ministry of Fisheries, Animal Husbandry and Dairying, Department of Animal Husbandry and Dairying, on deputation basis.

2. The Animal Welfare Board of India was set up in 1962 in accordance with the Section 4 of the Prevention of Cruelty to Animals Act, 1960 (No. 59 of 1960).

3. The following categories of officers are eligible for applying for the post of Secretary, AWBI :-

Officers under the Central Government or State Governments or Union Territory Administration:

(a) (i) holding analogous posts on regular basis in the parent cadre or department; or (ii) with five years regular service in the grade rendered after appointment thereto on regular basis in level-11 (Rs. 67700-208700) in the pay matrix or equivalent in the parent cadre or department; and (iii) having five years' experience in administration, organising conferences or training or seminars, having knowledge in Animal Welfare or Animal treatment, Veterinary Care and Animal Welfare Laws etc. in the Central Government or State Government or Union territories Administrations; and

(b) possessing the following educational qualifications and experience, namely:-

(i) Essential qualification:-

(A) Bachelor's degree in Veterinary Science or Bachelor degree in Veterinary Science and Animal Husbandry from a recognised University or equivalent specified in Final Schedule I or the Second Schedule to the Indian Veterinary Council Act, 1984 (52 of 1984) and registered with Veterinary council of India or State Veterinary Council; or

(B) Masters degree or Diploma in Zoology or Biological Sciences or environmental sciences or forestry or Wild Life Sciences;

(ii) Desirable qualification:-

(A) Master's degree in Veterinary Science in the field of Medicine or Surgery or Virology or Bacteriology or Microbiology or Immunology or Parasitology or Veterinary Public Health from a recognised University or equivalent; or

(B) Master's degree or Diploma in Zoology or Biological Sciences or environmental sciences or forestry or Wild Life Sciences.

Note 1: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceed three years.

Note 2: The maximum age-limit for appointment by deputation shall be not exceeding fifty-six years as on the last date of receipt of applications.

4. The pay and allowances and other terms will be regulated in accordance with the instructions issued by Department of Personnel & Training from time to time.
5. Willing and eligible officers whose services can be spared by Head of the Department immediately on selection should send their applications for the post in the prescribed proforma (Annexure-I & II) in duplicate to Director (Shri RPS Rathore), Animal Welfare Division, Ministry of Fisheries, Animal Husbandry and Dairying, Department of Animal Husbandry and Dairying, Krishi Bhavan, New Delhi within 60 days from the date of this letter along with the following documents:-
 - a. Integrity Certificate
 - b. Vigilance clearance certificate
 - c. Attested photocopies of the ACRs for the last five years (attested on each page by an officer not below the rank of an Under Secretary to the Govt. of India)
6. The Ministries/Department may ensure that the applicant fulfils all the eligibility conditions specified in para 3 above and also verify the particulars furnished by the applicants, before forwarding the application. Once the application is forwarded through proper channel, it will be presumed that concerned Department/Ministry has no objection in relieving of the said officer. Applications received after the due date or found incomplete will not be considered.
