OFFICE MEMORANDUM

Subject: Strengthening participation on the iGOT Karmayogi Platform and ensuring regular learning engagement by officers and officials of the Department – reg.

The undersigned is directed to state that the Government of India has been emphasizing continuous capacity building of civil servants through the iGOT Karmayogi platform under Mission Karmayogi.  - (v) completion of at least **one hour of learning activity every month** on the iGOT Karmayogi platform.
3. All the Divisional are requested to disseminate these instructions to all the attached/subordinate offices under their administrative control of this Department and to encourage their officers and officials to undertake regular learning activities on the iGOT Karmayogi platform and comply with the above instructions.. They **shall also put in place suitable monitoring mechanisms for periodic review** of learning progress and completion status.
4. The above measures are intended to promote a culture of continuous learning, strengthen institutional capacity and improve the Department's overall performance under the Mission Karmayogi framework.
