All the necessary packing materials like polyfilm, racks etc. and machines required for cutting of MS Racks shall be arranged by the party, electricity will be provided by DMS.

Special Terms & Conditions:

- 1. GST:** The price quoted shall be inclusive GST and all other Govt. levies etc.
- 2. Period of Contract:-** The above commodities have to be shifted within 30 days of issue of job order from this office by the shortlisted bidder, failing which the LD charges @ 2% per month basis shall be recovered.
- 3. Earnest Money Deposit (EMD):** Bidders are required to submit an Earnest Money Deposit (EMD) of ₹10,000/- (Rupees Ten Thousand only) through Demand Draft, Bankers Cheque or FDR in favor of General Manager, Delhi Milk Scheme payable at Delhi. Bids without valid EMD or valid Exemption Certificate (such as MSME/NSIC) will be summarily rejected. The EMD of unsuccessful bidders will be returned after the finalization of the tender.
- 4. Site Visit:** Consider the extensive requirement of the job /service, the bidders may visit the site for inspection and assessment of the work before providing their offer. Any clarification for the above job may be taken from Assistant Store Officer (R&G) on any working day between 10.00 AM to 4.00 PM. No request will be considered after opening of e-tender enquiry.

5. **Payment Terms:** The payment shall be made after completion of the Job and on submission of bills duly certified by Assistant Store Officer (R&G) to AO (I)/Store Payment for arranging payment. TDS will be deducted, if applicable.
6. **Documents:** The party is required to submit GST Certificate and Aadhar Card alongwith their bid offer.
7. **Statutory and Mandatory Provision:** The Bidder shall abide by all the statutory and mandatory provisions of labour/Industrial laws in force from time to time. In case any challan/ fine is levied under Statutory Act, DMS will not be responsible for any violation of law by Party and the contractor will be fully responsible for its settlement and of any statutory and the mandatory requirements such as Medical, Insurance etc.
8. **Compensation:** In the event of an accident or mishap resulting in any disability, injury or death of employee engaged by party during the period of the contract the compensation, damage etc. are to be paid by contractor. DMS shall not be liable in any manner either monetarily or otherwise.
9. **Safety Guidelines:** Tenderer should ensure that the staff deployed by him follow all statutory and safety guidelines while working. In this connection DMS in no way will be responsible for any untoward happenings during the contract period.
10. **Statutory Requirement:** The contractor is required to abide by all statutory requirements as per Law applicable during the contract period.
